Payment Date = The Banking Day on which the Bank performs the Payment Transaction. In the case of a Payment Transaction to an account in another bank or BankGiro/PlusGiro or via one of the BankGiro services, this is always a Banking Day. In the case of a Payment Transaction to an account in the Bank, this is all days of the week.

SEPA payment dates are dates defined by European Central Bank on which transactions may be processed. SEPA payment dates may be national holidays or other non-business days in Sweden (not including Saturdays or Sundays).

EEA currencies = SEK, EUR, BGN, CHF, CZK, DKK, GBP, HUF, NOK, PLN, RON, ISK

The Customer's approval takes place when he/she has given his/her consent to execute the Payment Transaction. For example, via Code Box, PIN Code, electronically sealing a file or signature.
